A NETWORK ORGANIZATION


Solidaridad employs over 1,000 staff members in 44 countries worldwide through seven regional expertise centers.

A Network Secretariat, connecting the regions, is located in Utrecht, the Netherlands. It consists of the Executive Director working with an on site and a footloose international team on tasks that support the whole network.

We don't just do the right things. We also want to do things right by adhering to the highest ethical principles and professional standards.


DIVERSITY AND INCLUSIVITY

The Solidaridad network structure was built on the idea that meaningful change grows from within communities. A collaborative work environment based on the exchange and debate of different ideas and perspectives will create the most innovative solutions. Diversity and representation of many different perspectives and identities is not just nice to have; it is essential to the mission of reclaiming sustainability.

Inclusion is prioritized at all levels of work within Solidaridad; from programming that promotes gender equality, to leadership within our Senior and Board level positions. A strong integrity structure supports open and honest dialogue and secure pathways for reporting and addressing issues.

All this makes up the core of what Solidaridad stands for: equity. Creating a more fair and equitable supply chain starts from our working culture and permeates through our programmes, communications and partnerships.





A TWO-TIER MODEL

Solidaridad has purposefully chosen to adopt a network structure based on local management, supervision, knowledge and expertise across the globe. The premise of the structure is that it promotes capacity building: strengthening Solidaridad teams in the region, enabling them to foster regional supervision and to manage programming themselves. The regional Solidaridad teams cooperate with their own partners on the planning, implementation, communication and evaluation of programmes, and on reporting their results.


The Executive Director (ED) is the legal representative and the public face on the global stage of the Solidaridad Network. The ED is the chairperson of the Executive Board of Directors of Solidaridad Network and as such reports directly to the International Supervisory Board (ISB). The director also acts as line manager for the Managing Directors of Solidaridad in the regional centers and heads Solidaridad's Network global secretariat.

RECLAIMING SUSTAINABILITY

As sustainability becomes mainstream, more and more companies are keen to show off their credentials through adopting different types of certification, labels and ethical commitments. But there is no such thing as sustainability when the people who produce those goods live in poverty and when natural resources are not managed sustainably.

The outdated idea of having only one success measure; profit, needs to end. We want to partner with CEOs and investors so they can lead this change, and move from false product claims to genuine sustainability policies, and from elite controlled supply chains to inclusive ownership models.

More of the price we pay for our food and products should go to the farmers and workers who made it, and our supply chains and infrastructure should be enabling and supporting them to farm and produce in sustainable ways.



THE POSITION

Solidaridad has an opening for a top-tier and entrepreneurially-spirited leader to inspire and lead our dynamic international network organization.

The Executive Director oversees the general management of the Solidaridad network and the proper execution of the strategic, governance, operational, financial and human resource objectives of Solidaridad.

As Executive Director you are the public face of the Solidaridad Network at the global level and responsible for the effective functioning and overall network results. This will require engagement with a wide range of stakeholders committed to change that matters, and the mobilization of new funding streams and partnerships.

This is a full-time position which can be executed from any of the countries in which we work.



RESPONSIBILITIES

These include, but are not limited to:

- Serve as the face of the organization and participate in external events to increase visibility, engagement, and credibility of the brand
- Develop strategic partnerships in close cooperation with the regions to further increase community awareness and expand programmes.
- Assure that Solidaridad Network as a whole is organized and managed effectively and efficiently and in line with its values.
- Create the conditions for an effective and inclusive work environment.
- Design, implement, enforce and provide oversight of global policies and processes
- Account for overall fundraising targets as well as financial sustainability
- Manage the central financial reserve of the organisation
- Asses financial consequences of strategic plans
- Manage the performance of the Network Secretariat.
- Periodically report to the International Supervisory Board
- Overall responsibility for annual budgets and financial reporting to the International Supervisory Board
